NO Payment that requires clearing such as a check. MMW does not provide live coverage. Breeding will be a side by side A.I. or shipped semen. 1-2 collections will be sent depending on timing. A single collection will be shipped not split. If buyer chooses to split, that is their choice.

Should said stud dog die, or become unable to sire a litter, MMW retains the right to approve a free stud service by another stud of MMW of equal or less value.

A "litter" is considered two puppies born alive. If a single puppy is produced then a repeat breeding is in order and has to be used within a year. Proof at 67 days or sooner must be provided with proof from a vet that pregnancy was not successful. Failure to provide proof voids contract. One repeat breeding then contract is void.

MMW has the right to refuse a repeat breeding if litter is born dead, or a bitches owner allows another stud to service bitch during the same season.

Upon receiving payment for service, MMW agrees to take appropriate action to officially approve the breeding for AKC registration only. Fees are absorbed by bitches owner.

3. If no progesterone testing is done on bitch and a litter does not occur, it is not dogs fault and only one repeat breeding will be allowed then fee will be forfeited. _____
4. If bitch dies before having a litter or during birth there is no refund. _____

5. Litter will be registered through AKC 3-7 weeks after pups are born. _____
6. Bitches owner will only use positive promotion on social media and other outlets when talking about the breeding, puppies, PJ Carter or MMW Bull Terriers. _____
7. They will inform MMW promptly when heat cycle starts. _____
8. Understands if a replacement bitch is used, MMW can refuse. Bitch must meet the same requirements listed above. _____
9. Puppies will not be rehomed until 8 weeks of age. _____
10. Puppies will be dewormed once at minimum and have their first vaccine before leaving. _____
11. No puppies from this breeding will be released to or given to any shelter, rescue, SPCA, humane society unless MMW agrees. _____
12. Colored photographs will be sent to MMW of puppies from birth to 8 weeks. _____
13. MMW is not responsible for genetic issues or illnesses puppies occur. _____
14. If needing assistance during whelping, MMW provides whelping services for a fee. _____
15. Puppies must be sold for a minimum of \$1500 pet price. _____
16. If Bitch owner is unable to care for puppies they are to be turned over to stud owner, not someone else. _____
